As per the discussions during the Pre-Bid Meeting held on 09.09.2016 regarding E-bid notice No.15675 dated 24-08-2016 for hiring of HR Agency, following clauses/provisions of the bid documents are amended/modified to the extent notified below:

1. Point No-2.4.4.1 of Section-I (ITB) is substituted as under :

Each bid must be accompanied by bid security of Rupees 20 Lac (2% of estimated cost) in form of DD/Bank Guarantee in accordance to provisions of the "Rajasthan Transparency in Public Procurement Act 2012 & Rule 2013" in favor of "Director, DLB, Jaipur" Payable at Jaipur.

2. A new paragraph is added at point No 2.4.4.1 of Section-I (ITB)

Provisions of Rule No-42 of RTPP Rules 2013, Shall be applicable for relaxation/ exemption of Earnest money (Bid security).

3. S. No. V. of Eligibility Criteria {point No 4.5 of Section-I (ITB)} is substituted as under :

The Bidder HR Agency should have the following experience of manpower supply to reputed Private Sector Companies (should be registered in Company Act) / Public Sector Companies/ Banks / Central or State Government Departments etc. as given below, any time during the past 3 years, excluding the current financial year (i.e. 2013-14, 2014-15, 2015-16):

Average annual contract/agreement/MoU amount should be minimum 5.00 Crore for outsourcing/providing of minimum 500 manpower in maximum 5 contract/ agreement/MoU.

4. Section 6A Point No 27.2 of Section VA. General Conditions of Contract (GCC) is Substituted as under :

The TEs shall be paid full honorarium right from the beginning i.e. date of joining. The other conditions of Para 27.2 will remain same


5. A new paragraph is added at point No 10.2.1 of Section-1 Instructions to Bidders (ITB)

Provisions of Rule No-75 of RTPP Rules 2013, Shall be applicable for relaxation /exemption of Performance security deposit.


