1. The Contractor shall be Authorized Converter of Original Retro reflective Sheeting Manufacturer and shall submit converter certificate issued by retro reflective sheeting manufacturer.  
Warranty and Durability – The contractor/ supplier is the authorized converter of sheeting manufacturer.
2. A certificate of having tested the sheeting for following properties and its having passed these tests shall be obtained from International/Government Laboratory Institute, by the manufacturer of the Sheeting.
  - (i) Coefficient of Retro Reflection
  - (ii) Day time color & luminance
  - (iii) 3 years outdoor weathering
  - (iv) Shrinkage
  - (vi) Flexibility
  - (vi) Liner Removal
  - (vii) Adhesion
  - (viii) Impact resistance
  - (ix) Specular gloss
  - (x) Fungus Resistance

3. The bidder shall submit 3 years outdoor weathering Test report of retro reflective sheeting from an Indian Lab from the manufacturers within 3 years of launching of product in India.
4. If bidders are giving an alternate certificate conforming to ASTM (D4956-09) on artificial accelerated weathering from an Indian Lab in lieu of above outdoor weathering test report from Indian Lab, then bidder shall submit the performance guarantee of nationalized bank issued by bidder/retro reflective sheeting manufacturer which shall be equivalent to the value of 10 % of complete tender and shall be valid till the warranty period (07 years for Type IV) of signages along with the bid submission or P.G. would be released after receipt of certificate meeting the requirement of three years outdoor weathering of the sheeting.

In case of testing of retro reflective sheeting (for accelerated outdoor weathering /3years outdoor weathering ) is going on : OEM must get a declaration from government lab conforming the same but bidder shall submit the performance guarantee of nationalized bank issued by bidder/retro reflective sheeting manufacturer which shall be equivalent to the value of 10 % of complete tender and shall be valid till the warranty period (07 years for Type IV) of signages along with the bid submission or P.G. would be released after receipt of certificate meeting the requirement of three years outdoor weathering of the sheeting.

5. After completion of work the contractor shall submit Warranty certificate (7 year for Type IV & 10 years for Type XI)in original for completion of installation of signboards as per requirement of IRC 67:2012. Warranty & Durability.
6. All sign boards to be dated during fabrication with indelible marking to indicate the date of manufacture of the road sign and actual date of installation at site in an unprotected outdoor exposure.. Warranty and Durability.
7. Documents as mention from point no. 1 to point no. 4 to be provide along with the Bid. Warranty shall be provided along with final bill at the time of completion of work.
