NOTIFICATION

In exercise of the powers conferred by section 337 of the Rajasthan Municipalities Act, 2009 (Act No.18 of 2009), the State Government hereby makes the following rules further to amend the Rajasthan Municipal (Administrative and Technical) Service Rules, 1963, namely:-

1. Short title and commencement.- (1) These rules may be called the Rajasthan Municipal (Administrative and Technical) Service (Forth Amendment) Rules, 2021.

(2) They shall come into force from the date of their publication in the Official Gazette.

2. Amendment of Schedule.- In schedule appended to the Rajasthan Municipal (Administrative and Technical) Service Rules, 1963,-

(i) under the head I-Administrative Officer, the existing entries of column number 5 against serial number 3 shall be substituted by the following, namely:-

" Five years experience in case of Executive Officer Class IV, Revenue Officer Grade II or Assessor and three years experience in case of Additional Administrative Officer."

(ii) under the head II-Technical Officers, the existing serial number 5 and entries thereto shall be substituted by the following, namely:-

5.	Senior Town Planner	100% by Promotion on the basis of merit cum seniority	Deputy Town Planner	5 years experience on the post of Deputy Town Planner and qualification as specified for the post of Assistant Town Planner.	-	-

(iii) under the head II-Technical Officer, the existing entries of column number 5 against serial number 6 shall be substituted by the following, namely:-

"Five years experience in case of Executive Officer Class IV, Revenue Officer Grade II or Assessor and three years experience in case of Additional Administrative Officer."


