**NOTIFICATION**

In exercise of the powers conferred by section 21 of the Rajasthan Lands and Buildings Tax Act, 1964 (Act No. 18 of 1964), the State Government being of the opinion that it is expedient in public interest so to do, hereby notifies that on deposit of fifty percent of the amount of lands and buildings tax by 30.09.2016 in cases assessed upto 31.03.2003, the remaining amount of lands and buildings tax along with interest and penalty shall be remitted on the following conditions, namely:-

- (i) that in cases where litigation is pending against the assessment order before any court the assessee shall submit a statement in form 'A' given below with proof of deposit of fifty percent of the due tax in the stipulated period and proof of withdrawal of suit, writ, appeal or revision etc, as the case may be, before the concerning Assessing Authority.
- (ii) that in cases where no litigation is pending against the assessment order before any court, the assessee shall submit a statement in form 'A' given below along with proof of deposit of fifty percent of the due tax in the stipulated period before the concerning Assessing Authority.
- (iii) that in case where any tax, interest or penalty have already been deposited before the date of issue of this notification the same shall not be refunded.




