Terms and Condition:-

A bidder/company participating in the procurement process shall possess the following minimum pre- qualification/eligibility criteria.

2. The company should be a Proprietorship firm/A company registered under Indian companies Act,1956/A partnership firm registered under Indian partnership Act,1932/Limited Liability partnership firm registered under limited liability partnership Act, 2008. The Firm shall have establish their office at Jaipur after award of work. The firm shall have to submit the affidavit for the same with agreement.
3. The company must have successfully executed /completed one or more assignments of Video wall in Central Govt./State Govt., Central/ State PSU in last three financial years. The bidder should attach copies in proof for the above eligibility conditions, copies of work orders, list of clients with contact details.]

4. The company should have a registered number of GST Registration Certificate with Income Tax Registration/Pan Number, P.F registration certification.
5. The company Authorization will be compulsory for bidder. The Company should be ISO 9000:1. Company should be having OEM product BIS certification. OEM must be having, CE, ROHA, certifications.
6. **Warranty Period:-**The bidder should give three years warranty for the Installed Video wall. The bidder should also maintain the Video wall if required and ensure proper working of boards during the period of warranty. The Agency shall have to arrange maintenance of the video wall within the 24 hours of lodging the complaint otherwise the penalty shall be levied as under;

For delay of 24 hrs to 48 hrs	Rs. 5000.00
For delay of 48 hrs to 72 hrs	Rs. 10000.00

If firm fails to do maintenance in above stated period, the maintenance shall be got done by RHB from any other expert agency on the risk & cost of the firm and action shall be taken against firm as per agreement.
7. **Security Deposit:-** Security deposit @10% shall be deducted from the bills. 5.00% of security deposit shall be refunded after 6 month from date of successful completion & handing over Video Wall to RHB and balance 5.00% security deposit shall be refunded after 60 days of completion of Warranty period.
