1. India has applied for financing from the Asian Development Bank (ADB) toward the cost of Rajasthan Secondary Towns Development Investment Program (RSTDIP). Part of this financing will be used for payments under the contract named above.

2. The Local Self Government Department represented by Rajasthan Urban Infrastructure Development Project (RUIDP); hereinafter referred to as the "Employer", invites online bids from eligible bidders for theCluster package of 2 towns in 2 Lots:-

a) Lot 1: Construction of Works of Water Supply Production and Distribution Network Improvements with house service connections for nonrevenue water reduction and continuous water supply and Providing Sewer Network with House connections, and construction of Sewage Treatment Plant and all allied Works and operation services of the entire system for 10 years at Khetri (Jhunjhunu).

b) Lot 2: Construction of Works of Water Supply Production and Distribution Network Improvements with house service connections for nonrevenue water reduction and continuous water supply and Providing Sewer Network with House connections, and construction of Sewage Treatment Plant, Sewage Pumping Station and all allied Works and operation services of the entire system for 10 years at

Mandawa (Jhunjhunu).

The scope includes works on rehabilitation and expansion of existing water distribution infrastructure to achieve continuous water supplywith house service connections; Providing sewer network with house connections, construction of sewage treatment plant, sewage pumping station & performance based operation, maintenance and management of the entire Water supply andsewerage system for 10 years on at Khetri and Mandawa.

3. For purposes of bidding, evaluation and award of contract, this package is treated as a single package. Contract for the Cluster package will be awarded to the lowest responsive bidder. On evaluation and determination of lowest bidder, separate notification of award for each Lot will be issued to the single successful bidder. Contract agreement will be signed Lot-wise and contract implementation and management will also be Lot-wise.

4. Open Competitive Bidding (OCB) - National will be conducted in accordance with ADB's Single-Stage: Two-Envelope bidding procedure and is open to all Bidders from eligible source countries as described in

the Bidding Document.

- 5. To be qualified for the contract package, the bidder should as a minimum meet the following requirements:
  - a) Average annual construction turnover of INR 730 million or its equivalent calculated as total certified payments received for contracts in progress or completed, within the last 3 years (Financial Year 2016-17, 2017-18 and 2018-19) or as per international practice.

b) Participation in at least:

one (1) contract in water supply that has been completed or substantially completed where the value of the work exceeds INR 296 million or its equivalent; or

 two (2) contracts in water supply that have been completed or substantially completed where the value of each work exceeds INR 211 million or its equivalent;

#### AND

- one (1) contract in sewerage work or Sewage Treatment Plant or Effluent Treatment Plant that has been completed or substantially completed where the value of the work exceeds INR 724 million or its equivalent; or
- two (2) contracts in sewerage work or Sewage Treatment Plant or Effluent Treatment Plant that have been completed or substantially completed where the value of each work exceeds INR 517 million or its equivalent;

Within the last 10 years (from 1 August, 2009up to the bid submission date);

- c) Meet other financial and experience requirements as indicated in the Bidding Document. However, for complete eligibility and qualification requirements, interested bidders should refer to the Bidding Document.
