**NOTIFICATION**

In exercise of the powers conferred by section 74 read with section 43 and 60 of the Rajasthan Urban Improvement Act, 1959 (Act No. 35 of 1959), the State Government hereby makes the following rules further to amend the Rajasthan Urban Improvement Trust (Disposal of Urban Land) Rules, 1974 and orders with reference to proviso to sub-Section (2) of section 74 of the said Act, that previous publication of these rules is dispensed with, as the State Government considers that, in the public interest, they should be brought into force at once, namely :-

**1. Short title and commencement.** – (1) These rules may be called the Rajasthan Improvement Trust (Disposal of Urban Land) (Amendment) Rules, 2012.

(2) They shall come into force at once.

**2. Deletion of rule 15-A.-** The existing rule 15-A of the Rajasthan Improvement Trust (Disposal of Urban Land) Rules, 1974 shall be deleted.


