

Expression of Interest (EOI)


Expression of Interest are invited from the organisations of repute to develop Bungee Jumping and Sky Cycling at Rajiv Gandhi Smriti Udhyan, Rani Road, near Fatehsagar Lake, Udaipur on PPP mode. Interested firms are requested to submit the detailed Expression of Interest to develop Bungee Jumping and Sky Cycling at Rajiv Gandhi Smriti Udhyan, Rani Road, Udaipur.

Interested firms must have experience in establishing minimum two number projects of Bungee Jumping and Sky Cycling in India along with successful running, operation & maintenance for at least three years. The firm interested will visit the location for the above activities and will carry out its feasibility for relevant activity, accordingly after approval from Urban Improvement Trust (UIT), Udaipur. Interested firm will also submit the detailed plan for establishment, operation and maintenance of bungee Jumping and Sky cycling adhering to relevant safety code while establishment of the facility and during its operation and maintenance. The firm should have the qualified and trained personnel to undertake the activity with relevant safety code following the occupational Standards for Tourism and Hospitality Industry. All the activities thus planned for public, must follow the National Occupational Standards in respective field of activity. The firm will also be responsible for obtaining all the statutory clearances/certificates required to establish, run and maintain such activities.

Firms are requested to propose the detailed plan and methodology for development of above facilities, their viability, feasibility, work plan for establishment and its operation and maintenance for Seven years from the operational date, after successful completion of the establishment with all the statutory clearances/certificates for each activity mentioned above. The firm shall propose a lumpsum lease rent per year to be paid to UIT by the firm in lieu of facilities and land space provided by UIT. A Firm, qualified in every respect with highest offer of lumpsum lease rent for 7 years, shall be awarded the work.

The facilities thus be developed shall not cascade any effect on scenic beauty and environmental health of lake and its surroundings. Bungee Jumping as well as Sky Cycling facilities to be developed shall be safe to be exercised and in harmony with environ of lake surrounding and ecology of the lake.
