For the above work, the rates offered by you for Execution of work and O&M has been approved in 11th Meeting of SLTC held on 18.07.2017 (minutes issued vide Jaipur letter no. F16 (AMRUT-08 Part) RUDSICO/AMRUT/ 2017-18/ 8181 dated 27.07.2017) with the following conditions:

- (i) Restricting of item no. 21 (Structural Steel work) of BoQ to 5440 kg (Final amount of item shall be Rs. 4,05,280 in place of Rs. 7,95,287.50)
- (ii) Deletion of Item no. 22 (Finishing of wall with delux multi surface paint, deletion of amount Rs. 4,91,521.50) of BoQ,
- (iii) Responsibility of compliance of entire RTPP process and AMRUT guidelines is on Municipal Council, Hanumangarh.
- (iv) Restricting the cost of plants to Rs. 10 lakhs and procuring the plants from nearest Govt. Nursery/ Forest Department,
- (v) Civil works to be restricted less than 15%.
- (vi) The O&M of items which are not part of bid shall be done by Municipal Council at its own level.

As asked vide this office letter dated 08.08.2017, you have shown your consent to agree with the above conditions in this contract vide your letter dated 14.08.2017. The necessary approval for sanction of Rs. 4000000.00 (Rupees forty Lakhs) for 3 year O&M has been given by the competent authority of the Municipal Council, Hanumangarh i.e. President, Municipal Council, Hanumangarh.
